# ORDER GRANTING BLANKET AUTHORIZATION TO IMPORT LIQUEFIED NATURAL GAS FROM CANADA BY TRUCK

DOE/FECM ORDER NO. 4854

AUGUST 4, 2022

#### 1. DESCRIPTION OF REQUEST

On July 5, 2022, Lovat Gas Solutions Ltd (Lovat Gas Solutions) filed an application with the Office of Fossil Energy and Carbon Management (FECM) of the Department of Energy (DOE) requesting blanket authorization under section 3 of the Natural Gas Act (NGA)<sup>1</sup> for the authority summarized in the list below. The applicant requests the authorization for a two-year term beginning on August 4, 2022. Lovat Gas Solutions is a Canada corporation with its principal place of business in Calgary, Alberta, Canada.

1. Import liquefied natural gas (LNG) from Canada by truck, up to a total volume equivalent to 0.01 billion cubic feet (Bcf) of natural gas, at any LNG receiving facility in the United States and its territories

## II. FINDING

DOE has evaluated the application to determine if the proposed import and/or export arrangement meets the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under NGA section 3(c), imports and exports of natural gas, including LNG, from or to any country with which the United States has entered into a free trade agreement (FTA) requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest.<sup>2</sup> DOE must grant such applications without modification or delay.<sup>3</sup> The authorization sought by Lovat Gas Solutions meets the NGA section 3(c) criteria, and, therefore, is deemed to be consistent with the public interest.

## <u>ORDER</u>

Pursuant to section 3(c) of the NGA, it is ordered that:

A. Lovat Gas Solutions is authorized for the activity described below. This authorization shall be effective for a two-year term beginning on August 4, 2022, and extending through August 3, 2024.

1. Import LNG from Canada by truck, up to a total volume equivalent to 0.01 Bcf of natural gas, at any LNG receiving facility in the United States and its territories

B. **Monthly Reports:** With respect to the imports and/or exports authorized by this Order, Lovat Gas Solutions shall file with the Office of Regulation, Analysis, and Engagement, within 30 days following the last day of each calendar month, a report on Form FE-746R indicating whether imports and/or exports have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no imports and/or exports have occurred, the report must provide the information specified for each applicable activity and mode of transportation, as set forth in the Guidelines for Filing Monthly Reports. C. The first monthly report required by this Order is due not later than September 30, 2022, and should cover the reporting period from August 4, 2022 through August 31, 2022.
