ORDER GRANTING LONG-TERM AUTHORIZATION
TO EXPORT LIQUEFIED NATURAL GAS TO FREE TRADE AGREEMENT NATIONS,
AND LONG-TERM AUTHORIZATION FOR SMALL-SCALE EXPORTS
OF LIQUEFIED NATURAL GAS

DOE/FECM ORDER NO. 4927

DECEMBER 13, 2022

I. INTRODUCTION

On September 26, 2022, Manifest Shipping & Trading Corp. (MST) filed an Application¹ with the Department of Energy’s (DOE) Office of Fossil Energy and Carbon Management (formerly the Office of Fossil Energy)² under section 3 of the Natural Gas Act (NGA),³ requesting long-term authorization⁴ to export domestically produced liquefied natural gas (LNG). MST requests a long-term authorization to export LNG as follows:

- (i) Under section 3(c) of the NGA, to any country with which the United States has, or in the future enters into, a free trade agreement (FTA) requiring national treatment for trade in natural gas (FTA countries),⁵ and
- (ii) Under section 3(a) of the NGA, to any other country with which trade is not prohibited by United States law or policy (non-FTA countries).⁶

MST states that its proposed non-FTA exports qualify as “small-scale natural gas exports” under DOE’s regulations at 10 C.F.R. §§ 590.102(p) and 590.208(a), and therefore should be deemed to be consistent with the public interest under NGA section 3(a).⁷

MST seeks to export this LNG in a total volume equivalent to 51.75 billion cubic feet (Bcf) per year (Bcf/yr), or 0.14 Bcf per day (Bcf/d), of natural gas.⁸ MST states that it intends to source the LNG primarily from small-scale liquefaction and peak shaving facilities located in the United States.⁹ In Appendix A to the Application, MST identifies two existing facilities from which it seeks to purchase LNG for export: (i) the JAX LNG facility (Port of Jacksonville, Florida), and (ii) the Puget LNG facility (Port of Tacoma, Washington) (collectively, the Facilities).¹⁰ MST further states that it intends to load the LNG for export in two ways: onto small-scale vessels directly from marine terminals, and onto small-scale vessels directly from Jones Act-compliant barges in U.S. ports.¹¹

MST requests that its authorization commence on the date of first commercial export and extend through December 31, 2050.¹² Additionally, MST requests authority to export the LNG on its own behalf and as agent for other entities that hold title to the LNG at the time of export.¹³

In this consolidated Order, DOE grants MST's Application and authorizes the requested export volume of 51.75 Bcf/yr (0.14 Bcf/d) to both FTA and non-FTA countries on a non-additive basis. Specifically, DOE finds that the FTA portion of the Application falls within NGA section 3(c), and we therefore grant the requested FTA authorization without modification or delay.¹⁴ DOE also finds that the proposed non-FTA exports qualify as "small-scale natural gas exports" under the criteria set forth in 10 C.F.R. § 590.102(p). Accordingly, we grant the small-scale portion of the Application under 10 C.F.R. § 590.208(a).

This Order, however, does not provide MST with an independent right to purchase or load LNG at any of the Facilities. DOE takes no position on the commercial arrangements that may be necessary for MST to effectuate the export of LNG approved in this Order.

II. BACKGROUND

Applicant. MST is a Delaware corporation with its principal place of business in Westport, Connecticut. MST states that it has three shareholders: Tanbark Holdings, LLC, a Texas limited liability company (34%); Instow Energy Ltd, a United Kingdom private limited company (33%); and D&P Energy Holdings Limited, a United Kingdom private limited company (33%).¹⁵ MST further states that three individuals own each of its three shareholders: John Lindquist, a United States citizen, owns Tanbark Holdings, LLC; Nicholas Browne, a United Kingdom citizen, owns Instow Energy Ltd; and Martyn McMahon, a United Kingdom citizen, owns D&P Energy Holdings Limited.¹⁶

Liquefaction Facilities and Transport. MST states that it intends to source LNG primarily from existing small-scale liquefaction and peak shaving facilities located in the United States—specifically, the JAX LNG and Puget LNG facilities.¹⁷ MST states that it will load the LNG for export onto small-scale vessels directly from both marine terminals and from Jones Act-compliant barges in U.S. ports.¹⁸ MST states that it intends to export the LNG to “allies of the United States in Europe, Asia, and Latin America.”¹⁹

Source of Supply. MST states that the source of the proposed exports will be the natural gas supply produced throughout the United States and delivered to the Facilities through the

integrated natural gas pipeline grid.²⁰

Business Model. MST requests authorization to export LNG on its own behalf and as agent for other entities that hold title to the LNG at the time of export.²¹ MST states that, although it has not yet executed any contracts to purchase LNG, it “is in the process of negotiating binding agreements with multiple existing liquefaction facilities interested in supplying LNG to MST for exportation.”²² MST states that it will file, or cause to be filed, all long-term commercial agreements, once executed, in accordance with DOE’s established policy, and will comply with all DOE requirements for exporters and agents, including registration requirements.²³

III. STANDARD OF REVIEW

A. FTA Authorization

Section 3(c) of the NGA was amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). In relevant part, applications to export natural gas, including LNG, to countries with which there is a FTA in effect requiring national treatment for trade in natural gas “shall be deemed to be consistent with the public interest” and granted “without modification or delay.”²⁴

B. Small-Scale Authorization

DOE defines a “small-scale natural gas export” as an export of natural gas, including LNG, to a non-FTA country that meets the following two criteria:

- (1) The application proposes to export natural gas in a volume up to and including 51.75 billion cubic feet per year, and
- (2) DOE’s approval of the application does not require an environmental impact

statement (EIS) or an environmental assessment (EA) under the National Environmental Policy Act, 42 U.S.C. 4321 *et seq.*²⁵

Small-scale natural gas exports are deemed to be consistent with the public interest under NGA section 3(a).²⁶ Therefore, DOE will issue an export authorization upon receipt of a complete application to conduct small-scale natural gas exports.²⁷

IV. DISCUSSION AND CONCLUSIONS

A. FTA Authorization

We find that the FTA portion of MST's Application falls within NGA section 3(c), and therefore we grant the requested FTA authorization without modification or delay.²⁸

B. Small-Scale Authorization

We find that the non-FTA portion of the Application meets the criteria for small-scale natural gas exports, set forth in 10 C.F.R. § 590.102(p). First, MST requests authority to export LNG to non-FTA countries in a volume equivalent to 51.75 Bcf/yr of natural gas, which is consistent with the limit in the regulation. Second, DOE's National Environmental Policy Act (NEPA) procedures provide for a categorical exclusion if neither an EIS nor an EA is required—specifically, categorical exclusion B5.7 (10 C.F.R. Part 1021, Subpart D, Appendix B5), *Export of natural gas and associated transportation by marine vessel*.²⁹ On December 13, 2022, DOE issued a categorical exclusion for the non-FTA portion of MST's Application under this provision.³⁰ Accordingly, pursuant to 10 C.F.R. § 590.208(a), the proposed small-scale exports

are deemed to be consistent with the public interest under NGA section 3(a), and DOE grants the requested authorization.

V. FINDINGS

Based on the findings and conclusions herein, DOE grants the Application subject to the Terms and Conditions and Ordering Paragraphs set forth below.

VI. TERMS AND CONDITIONS

A. Term of the Authorization

Consistent with DOE's practice, MST requests that its FTA and small-scale non-FTA authorizations commence on the date of first commercial export and end on December 31, 2050.³¹ Accordingly, the term for this authorization will commence on the date of first commercial export and extend through December 31, 2050.

B. Commencement of Operations for Small-Scale Authorization

DOE will add as a condition of the small-scale authorization that MST must commence commercial LNG export operations no later than two years from the date of issuance of this Order. Because this Order allows for exports to begin from existing facilities, we find that MST should be able to commence small-scale exports of LNG immediately.

C. FTA Countries for FTA Authorization

The countries with which the United States has a FTA requiring national treatment for trade in natural gas are currently: Australia, Bahrain, Canada, Chile, Colombia, Dominican Republic, El Salvador, Guatemala, Honduras, Jordan, Mexico, Morocco, Nicaragua, Oman, Panama, Peru, Republic of Korea, and Singapore.

D. Transfer, Assignment, or Change in Control

DOE's natural gas regulations prohibit authorization holders from transferring or assigning authorizations to import or export natural gas without specific authorization by the Assistant Secretary for Fossil Energy and Carbon Management.³² DOE has found that this requirement applies to any change in control of the authorization holder. This condition was deemed necessary to ensure that DOE will be given an adequate opportunity to assess the public interest impacts of such a transfer or change.

DOE construes a change in control to mean a change, directly or indirectly, of the power to direct the management or policies of an entity, whether such power is exercised through one or more intermediary companies or pursuant to an agreement, written or oral, and whether such power is established through ownership or voting of securities, or common directors, officers, or stockholders, or voting trusts, holding trusts, or debt holdings, or contract, or any other direct or indirect means.³³ A rebuttable presumption that control exists will arise from the ownership or the power to vote, directly or indirectly, 10% or more of the voting securities of such entity.³⁴

E. Agency Rights

MST requests authorization to export LNG on its own behalf and as agent for other entities that hold title to the LNG at the time of export. DOE previously has determined that, in LNG export orders in which Agency Rights have been granted, DOE shall require registration materials filed for, or by, an LNG title-holder (Registrant) to include the same company

identification information and long-term contract information of the Registrant as if the Registrant had filed an application to export LNG on its own behalf.³⁵

To ensure that the public interest is served, this authorization shall be conditioned to require that where MST proposes to export LNG as agent for other entities that hold title to the LNG (Registrants), it must register with DOE those entities on whose behalf it will export LNG in accordance with the procedures and requirements described herein.

F. Contract Provisions for the Sale or Transfer of LNG to be Exported

DOE will require that MST file or cause to be filed with DOE any relevant long-term commercial agreements associated with the export of LNG, including agreements pursuant to which MST intends to export LNG as agent for a Registrant. DOE finds that the submission of all such agreements or contracts within 30 days of their execution using the procedures described below will be consistent with the “to the extent practicable” requirement of section 590.202(b) of DOE’s regulations.³⁶

In addition, DOE finds that section 590.202(c) of DOE’s regulations³⁷ requires that MST file, or cause to be filed, all long-term contracts associated with the long-term supply of natural gas to the Facilities, whether signed by MST or the Registrant, within 30 days of their execution.

DOE recognizes that some information in MST’s or a Registrant’s long-term commercial agreements associated with the export of LNG, and/or long-term contracts associated with the long-term supply of natural gas to the Facilities, may be commercially sensitive. DOE therefore

will provide MST the option to file or cause to be filed either unredacted contracts, or in the alternative (A) MST may file, or cause to be filed, long-term contracts under seal, but it also will file either: (i) a copy of each long-term contract with commercially sensitive information redacted, or (ii) a summary of all major provisions of the contract(s) including, but not limited to, the parties to each contract, contract term, quantity, any take or pay or equivalent provisions/conditions, destinations, re-sale provisions, and other relevant provisions; and (B) the filing must demonstrate why the redacted information or non-disclosed information should be exempted from public disclosure.³⁸

To ensure that DOE destination and reporting requirements included in this Order are conveyed to subsequent title holders, DOE will include as a condition of this authorization that future contracts for the sale or transfer of LNG exported pursuant to this Order shall include an acknowledgement of these requirements.

G. Export Quantity

This Order grants MST's Application in the full volume of LNG requested, up to the equivalent of 51.75 Bcf/yr of natural gas for FTA and non-FTA countries.

H. Non-Additive Export Volumes

Consistent with DOE's small-scale export regulations, MST may not treat the FTA and small-scale non-FTA volumes in this Order as additive to one another.

VII. ORDER

Pursuant to section 3 of the Natural Gas Act, it is ordered that:

A. Manifest Shipping & Trading Corp. (MST) is authorized by DOE to export domestically produced LNG purchased from the two Facilities listed in Appendix A of the

Application.³⁹ MST is authorized to load this LNG for export onto small-scale vessels directly from both marine terminals and from barges in U.S. ports, in a volume equivalent to 51.75 Bcf/yr of natural gas. The FTA and small-scale authorizations will commence on the date of first commercial export and extend through December 31, 2050. MST is authorized to export this LNG on its own behalf and as agent for other entities that hold title to the natural gas, pursuant to one or more contracts of any duration.⁴⁰

B. This Order does not give MST an independent right to purchase or load LNG from the identified Facilities. MST and each Facility may agree upon contractual terms for MST's export services, as they deem appropriate. Additionally, this Order does not restrict, through volume limitations or otherwise, any existing or future authorizations issued by DOE for the Facilities.⁴¹

C. Exports of LNG under this Order may be exported by vessel to any country with the capacity to import LNG, and with which trade is not prohibited by U.S. law or policy.

D. For the authorization to non-FTA countries under the Small-Scale Rule, MST must commence export operations using the Facilities no later than two years from the date of issuance of this Order.

E. MST shall ensure that all transactions authorized by this Order are permitted and lawful under U.S. laws and policies, including the rules, regulations, orders, policies, and other determinations of the Office of Foreign Assets Control of the U.S. Department of the Treasury, the Federal Energy Regulatory Commission, and the Pipeline and Hazardous Materials Safety

Administration of the U.S. Department of Transportation, as applicable. Failure to comply with these requirements could result in rescission of this authorization and/or other civil or criminal penalties.

F. (i) MST shall file, or cause others to file, with the Office of Regulation, Analysis, and Engagement an unredacted copy of all executed long-term contracts associated with the long-term export of LNG. The unredacted copies must be filed within 30 days of their execution and may be filed under seal, as described above.

(ii) MST shall file, or cause others to file, with the Office of Regulation, Analysis, and Engagement a non-redacted copy of all executed long-term contracts associated with the long-term supply of natural gas to the Facilities. The unredacted copies must be filed within 30 days of their execution and may be filed under seal, as described above.

G. MST is permitted to use its authorization to export LNG as agent for other LNG titleholders (Registrants), after registering those entities with DOE. Registration materials shall include an agreement by the Registrant to supply MST with all information necessary to permit MST to register that person or entity with DOE, including: (1) the Registrant's agreement to comply with this Order and all applicable requirements of DOE's regulations at 10 C.F.R. Part 590, including but not limited to destination restrictions; (2) the exact legal name of the Registrant, state/location of incorporation/registration, primary place of business, the Registrant's ownership structure, including the ultimate parent entity if the Registrant is a subsidiary or affiliate of another entity; (3) the name, title, mailing address, e-mail address, and telephone number of a corporate officer or employee of the Registrant to whom inquiries may be directed; and (4) within 30 days of execution, a copy of any long-term contracts not previously filed with DOE, described in Ordering Paragraph F of this Order.

Any change in the registration materials—including changes in company name, contact information, length of the long-term contract, termination of the long-term contract, or other relevant modifications—shall be filed with DOE within 30 days of such change(s).

H. MST, or others for whom MST acts as agent, shall include the following provision in any agreement or other contract for the sale or transfer of LNG pursuant to this Order:

Customer or purchaser acknowledges and agrees that it will resell or transfer LNG, purchased hereunder for delivery only to countries identified in Ordering Paragraph C of DOE/FECM Order No. 4927, issued December 13, 2022, in Docket No. 22-124-LNG, and/or to purchasers that have agreed in writing to limit their direct or indirect resale or transfer of such LNG to such countries. Customer or purchaser further commits to cause a report to be provided to Manifest Shipping & Trading Corp. that identifies the country (or countries) into which the LNG was actually delivered, and to include in any resale contract for such LNG the necessary conditions to ensure that Manifest Shipping & Trading Corp. is made aware of all such actual destination countries.

I. Within two weeks after the first export authorized in Ordering Paragraph A occurs, MST shall provide DOE written notification of the date on which the first export occurred.

J. With respect to any change in control of the authorization holder, MST must comply with DOE's Procedures for Change in Control Affecting Applications and Authorizations to Import or Export Natural Gas.⁴²

K. Monthly Reports: With respect to the exports authorized by this Order, MST shall file with the Office of Regulation, Analysis, and Engagement, within 30 days following the last day of each calendar month, a report on Form FE-746R indicating whether exports of LNG have been made. The first monthly report required by this Order is due not later than the 30th day of the month following the month of first export. In subsequent months, if exports have not occurred, a report of "no activity" for that month must be filed. If exports have occurred, the report must provide the information specified for each applicable activity and mode of
